- f. The applicable and appropriate method of procurement and the related milestones: Public Bidding: Single LOT
- g. The prospective bidders are given to raise their Queries and clarification until Feb. 10, 2023, 5:00 pm under 22.5.1. Requests for clarification(s) on any part of the Bidding Documents or for an interpretation must be in writing and submitted to the BAC of the Procuring Entity concerned at least ten (10) calendar days before the deadline set for the submission and receipt of bids. The BAC shall respond to the said request by issuing a Supplemental/Bid Bulletin, duly signed by the BAC Chairperson, to be made available to all those who have properly secured the Bidding Documents, at least seven (7) calendar days before the deadline for the submission and receipt of bids.
- h. Eligibility requirements the prospective bidders need to submit are included in the Bidding Documents and the former are advised to read such;
- i. Discussion on the evaluation procedure and criteria under 30.1. For this purpose, the BAC shall check the submitted documents of each bidder against a checklist of required documents to ascertain if they are all present, using a non-discretionary "pass/fail" criterion, as stated in the Instructions to Bidders. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed."
- j. Reminded the body the possible causes of failure of bidding, grounds for disqualification, suspension and blacklisting; that It is mentioned in the BID DOCUMENTS, in case of Bid Securing Declaration, there is a waiver of due process for blacklisting and automatic blacklisting in case of violation of any conditions stated.
- k. Reminded the body the prospective bidders regarding the Right of the HoPE under Section 41 (reservation clause): The HoPE reserves the right;
 - i. to reject any and all bids
 - ii. declare a failure of bidding, or
 - iii. not award the contract in the following situations:
 - 1. If there is prima facie evidence of collusion
 - 2. If the BAC is found to have failed in following the prescribed bidding procedures; or
 - 3. the award of the contract will not redound to the benefit of the CSU.

II. Noted comment/reaction from the BAC, TWG and End-user:

- 1. The prospective expressed, if won, that the warranty is guaranteed despite installation will be done by the end-user
- 2. The Committee, though the BAC Secretariat, clarified that under GPPB CIRCULAR 04-2020, 16 September 2020 the Statement of the Bidder of All its Ongoing Government and Private Contracts Including the Contract Awarded but Not Yet Started should properly state the following:
 - i. Names of outstanding contracts with other contracting party, i.e., PE or private company allowed by the rules,
 - ii. contract date,
 - iii. period
 - iv. and amount or value; and
 - v. kinds of Goods
 - vi. dates of delivery,
- 3. The Committee further emphasized while there is no mandatory form or format as to Statement of the Bidder of All its Ongoing Government and Private Contracts Including the Contract Awarded but Not Yet Started, the above information or data are mandatory and failure to state/declare or misrepresentation of such is a ground to disqualify the bidder.
- 4. In response to bidder's query, the Committee clarified that supporting documents are likewise mandatory in the List of Bidder's All Ongoing Government and Private Contracts Including the Contract Awarded but Not Yet Started as well as in Bidder's Single Largest Completed Contract.
- 5. The Committee advised the prospective bidders to refer to the bidding documents for better information but may send queries or clarifications later within the allowable period.

There having no other remaining topics for discussion, the Prebid Conference adjourned at 11:00 am.
